NARRATIVE

ON SATURDAY, FEBRUARY 19, 2022 AT APPROXIMATELY 7:45AM, OFFICERS DONALD SHARP AND SEMAJ JOHNSON, MANNING UNIT 782A, OF THE NEW ORLEANS POLICE DEPARTMENT SEVENTH DISTRICT, WERE DISPATCHED TO A SIGNAL 24, MEDICAL, WHICH WAS REPORTED AT NEW ORLEANS EAST HOSPITAL, 5620 READ BOULEVARD. THIS INCIDENT WAS ASSIGNED N.O.P.D. ITEM NUMBER B-22364-22. THIS SIGNAL WOULD LATER BE CHANGED TO A 29U, UNCLASSIFIED DEATH.

UPON ARRIVAL THE OFFICERS MET WITH THE REPORTING PERSON, [REDACTED], NURSE AT NEW ORLEANS EAST HOSPITAL. [REDACTED] ADVISED THE VICTIM, UNKNOWN WHITE FEMALE, APPROXIMATE AGE BETWEEN LATE TWENTIES AND EARLY THIRTIES WAS BROUGHT INTO THE HOSPITAL AT APPROXIMATELY 6:41 AM. WHEN THE VICTIM WAS DELIVERED TO THE HOSPITAL, SHE WAS BLUE AND HER PUPILS WERE FIXED AND DILATED. THE VICTIM SHOWED NO OBVIOUS SIGNS OF PHYSICAL INJURY.

THE VICTIM WAS DECLARED DECEASED AT 7:07 AM, BY EMERGENCY ROOM DOCTOR LOBAT.

[REDACTED] ADVISED THE CORONER'S OFFICE WAS ALREADY CALLED AND WERE ENROUTE TO COLLECT THE VICTIM.

THE OFFICERS SPOKE WITH SEVERAL OF THE HOSPITAL SECURITY, AS THE SECURITY OFFICERS, WHO WERE WORKING WHEN THE VICTIM WAS DELIVERED, WERE NO LONGER WORKING. THESE SECURITY OFFICERS STATED A MALE NAMED [REDACTED] DROPPED OFF THE VICTIM STATING HE WAS AN UBER DRIVER. [REDACTED] WAS DRIVING A 2019 TOYOTA CAMRY, BEARING LOUISIANA LICENSE PLATE [REDACTED] AND WAS NO LONGER AT THE HOSPITAL.

SERGEANT PERRIN GAINES, MANNING UNIT 730A WAS NOTIFIED AND ARRIVED ON SCENE.

DETECTIVE SHONNDELL FIELDS, MANNING UNIT 1734, WAS NOTIFIED AND ARRIVED ON SCENE.

HOMICIDE DETECTIVE TANISHA SMITH, MANNING UNIT 4161, ARRIVED ON SCENE.

CRIME LAB TECHNICIAN C. MUSALL, MANNING UNIT 5113 ARRIVED ON SCENE AND PHOTOGRAPHED THE VICTIM.

THE OFFICERS CONDUCTED A NAME AND VEHICLE CHECK, CONCERNING [REDACTED] AND HIS TOYOTA CAMRY, BEARING LOUISIANA LICENSE [REDACTED]. [REDACTED] LEARNED THE LAST KNOWN ADDRESS FOR [REDACTED] WAS 77 [REDACTED] ARCADIA LANE AND HIS 2019 TOYOTA CAMRY WAS ALSO REGISTERED TO THAT ADDRESS.

THE OFFICERS AND DETECTIVE SHONNDELL FIELDS DROVE TO 77 [REDACTED] ARCADIA LANE, IN ORDER TO SPEAK WITH [REDACTED], CONCERNING THE CIRCUMSTANCES, BY WHICH, HE CAME TO DELIVER THE VICTIM TO NEW ORLEANS EAST HOSPITAL.

UPON ARRIVAL, THE OFFICERS LOCATED THE 2019 TOYOTA CAMRY PARKED IN THE DRIVEWAY, HOWEVER; WERE ADVISED [REDACTED] WAS NOT AT THE RESIDENCE BUT AT A RESIDENCE "ON THE WESTBANK".

THE OFFICERS CHANGED THE SIGNAL TO A 29U, AND DOCUMENTED THIS REPORT.

THE OFFICERS' BODY WORN CAMERAS AND IN CAR CAMERAS WERE ACTIVATED DURING THIS INVESTIGATION.

FURTHER INVESTIGATION WILL BE DOCUMENTED IN A SUPPLEMENTAL REPORT.
